### Dents



- Up to three per panel with diameter up to 101.6 mm (4")

- Four or more scratches or dents less than 101.6 mm (4")
- One scratch or dent greater than 101.6 mm (4")

### Glass



- Up to three scratches 101.6 mm (4") or less

- Four or more scratches
- One scratch greater than 101.6 mm (4")
- All chips and cracks are chargeable

### Wheels and Tires



#### Wheels

- Scratches or gouges 152.4 mm (6") or less

#### Tires

- No sidewall damage or plugs
- Replacement tires, including winter tires, left on the original rim
- Tires that have 3.2 mm (1/8") or more of tread in all grooves

#### Wheels

- Scratches or gouges greater than 152.4 mm (6")

#### Tires

- Any sidewall damage or plugs
- Replacement tires, including winter tires, not left on the original rim
- Tires that have less than 3.2 mm (1/8") of tread in all grooves

### Bumper



- Dents 101.6 mm (4") or less

- Dents greater than 101.6 mm (4")
